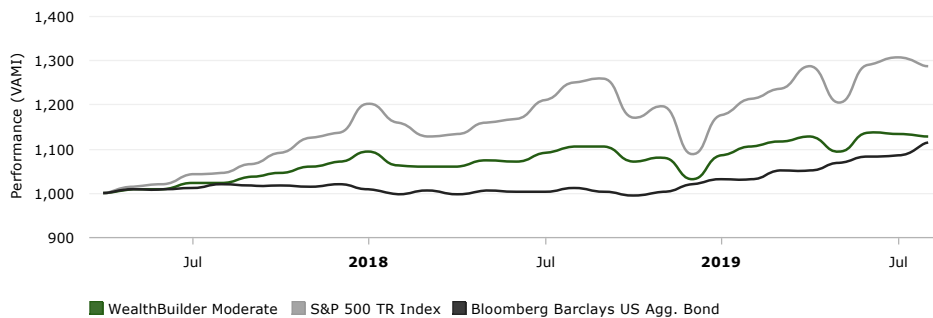

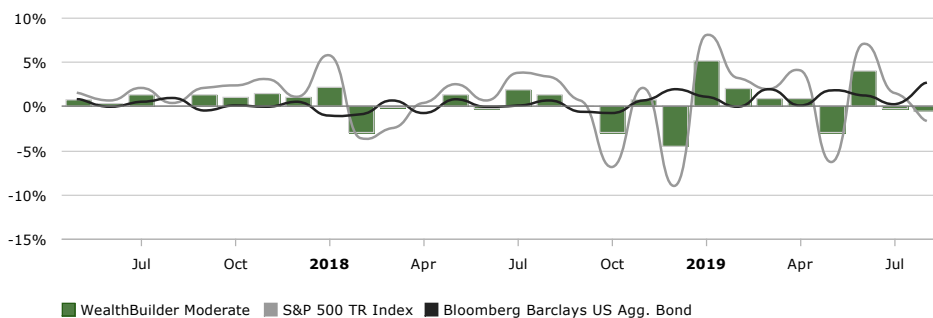
## INVESTMENT STRATEGY

### Definitions

**12-Month Trailing Yield:** the income collected on an investment over the prior 12 months, such as the interest or dividends. The yield shown in this fact sheet is the weighted average trailing 12 month yield of the portfolio. This is the percentage income the portfolio returned over the past 12 months through distributions and stock dividends.

**Sharpe Ratio:** the Sharpe ratio (also known as the Sharpe index, the Sharpe measure, and the reward-to-variability ratio) is a way to examine the performance of an investment by adjusting for its risk. The ratio measures the excess return (or risk premium) per unit of deviation in an investment asset or a trading strategy, typically referred to as risk, named after William F. Sharpe.

**Maximum Drawdown:** A maximum drawdown (MDD) is the maximum loss from a peak to a trough of a portfolio, before a new peak is attained. Maximum Drawdown (MDD) is an indicator of downside risk over a specified time period. It can be used both as a stand-alone measure or as an input into other metrics such as "Return over Maximum Drawdown" and the Calmar Ratio. Maximum Drawdown is expressed in percentage terms and computed as:  $MDD = (Trough\ Value - Peak\ Value) \div Peak\ Value$

**Annualized Standard Deviation:** The Annualized Standard Deviation is the **standard deviation multiplied by the square root of the number of periods in one year**. Standard deviation of return measures the average deviations of a return series from its mean, and is often used as a measure of risk.
